

SURVEY RESULTS OF NGOs IN UKRAINE

Global Network of People living with HIV (GNP+) in collaboration with Light of Hope (Ukraine)

25.07.2022 - 04.08.2022

The survey involved 36 Ukrainian NGOs, which were respondents in the first part of the survey, regarding the identification of the existing needs of key and vulnerable populations (NGO's clients). Which is 60% of the total number of unique participants who work in the field of HIV/TB.

To conduct the study, the method of online survey of organizations using the Google Forms web application was used. The purpose of the study was to assess the potential of NGOs in Ukraine in the direction of working with humanitarian aid under martial law.

THE FOLLOWING BARRIERS WERE REVEALED FROM THE RESULTS OF THE SURVEY:

NGO POLICIES

Absence:

- ✓ In the Charter of an NGO, the directions of humanitarian assistance or the target group of IDP;
- ✓ Providing of residential/shelter services to NGO clients are not included in classifier of types of activities they allowed to carry on ;
- ✓ Child Protection Policy, Sexual Abuse and Exploitation Policy, Eco Policy, etc.

FINANCIAL MANAGEMENT

Absence:

- ✓ NGO experience in accounting and reporting in the context of organizing humanitarian aid;
- ✔ Audit Reports;
- ✓ Annual reports of NGOs.

HUMAN RESOURCES

Недостаточно:

- Resources for the branch and development of a new direction of humanitarian aid NGOs;
- ✓ Knowledge and skills for the development of new activities of NGOs (humanitarian aid, shelters).

TECHNICAL CAPACITY

- ✓ In 90% of NGOs, storage facilities for storing humanitarian aid have an area of less than 60 sq.m.
- ✓ 14 NGOs mobile outpatient clinics of the MFB "Alliance of Public Health».

COOPERATION WITH THE GOVERNMENT

- ✓ Absence of long-term agreements, memorandums of cooperation/partnership, etc
- ✓ Insufficient informing of the authorities about the activities of NGOs;
- ✓ The activities of organizations are not part of local policies and are not included in the social infrastructure of the city/region.

VIABILITY/SUSTAINABILITY OF NGOs

- ✓ 90% of NGOs do not receive budget funding for the functioning of the humanitarian direction, support for the work of shelters;
- ✓ Short-term donor programs (2-3 months);
- ✓ Lack of permanent partners in the field of humanitarian aid, shelters;
- ✓ Funding sources are not diversified.
